IN 2014, FRIENDS OF THE HIGH LINE (FHL) CONTINUED WORK ON SEVERAL LARGE SCALE CAPITAL CONSTRUCTION PROJECTS, ADVANCED EARLY DESIGN PHASES FOR ADDITIONAL LARGE SCALE PROJECTS, MANAGED A VARIETY OF CAPITAL IMPROVEMENTS ON THE EXISTING HIGH LINE AND IMPLEMENTED ADVOCACY EFFORTS FOCUSING ON STRATEGIC URBAN PLANNING INITIATIVES. CONSTRUCTION ON PHASE I OF SECTION 3 WAS COMPLETED AND OPENED TO THE PUBLIC IN SEPTEMBER OF 2014. WORK ON PHASE I IN 2014 WAS PRIMARILY FOCUSED ON THE TOP SIDE LANDSCAPE ARCHITECTURE, INCLUDING WALKING SURFACES, SEATING AND PLAY FEATURES, PLANTINGS AND IRRIGATION, AND LIGHTING.
