IN 2015, FRIENDS OF THE HIGH LINE (FHL) SUCCESSFULLY OPERATED AND MAINTAINED SECTIONS 1, 2, AND 3 OF THE PARK, FROM GANSEVOORT STREET TO WEST 34TH STREET. VISITATION WAS APPROXIMATELY 7.6 MILLION PEOPLE. IN ORDER TO APPROPRIATELY MANAGE THE GARDENS, THE HORTICULTURE TEAM PLANTED 5,500 PERENNIALS AND GRASSES, 4,400 BULBS, AND 54 TREES AND SHRUBS. THE FACILITIES PLANNING & MANAGEMENT TEAM MANAGED AND MAINTAINED THE PHYSICAL PLANT OF THE PARK, INCLUDING THE HIGH LINE HEADQUARTERS (HLHQ) AT 820 WASHINGTON STREET, WITH A COMBINED 20,000 S.F.
