FHL CONTINUED TO FOCUS ON MAINTENANCE, CLEANLINESS AND SAFETY TO ENHANCE THE VISITOR EXPERIENCE. VISITATION WAS APPROXIMATELY 7.8 MILLION PEOPLE. IN ORDER TO APPROPRIATELY MANAGE THE GARDENS, THE HORTICULTURE TEAM PLANTED 8,000 PERENNIALS AND GRASSES, 9,850 BULBS, AND 83 TREES AND SHRUBS.
